2019 2nd Quarter Training

Range Day and Duty Ammunition Exchange

Pistol, Rifle (personally-owned optional rifle and / or patrol car rifle), Shotgun, Off duty / back-up

BRING:

Please bring your duty pistol, shotgun, and rifle ammunition with you to exchange. Patrol supervisors: please ensure your deputies arrange to bring shotguns and rifles from patrol vehicles so that the ammunition may be exchanged. In an effort to maintain consistency, long guns must be on-site to have the ammunition replaced. We will only be issuing pistol ammunition for magazines on your duty belt (sorry, we won't fill up your 33 round Glock magazine).

Uniform of the Day:

Please wear proper range attire with your ballistic vest and full Sam Browne belt.

When You Arrive at the Range:

All off duty / back-ups, patrol rifles, and shotguns shall be unloaded.

Please keep your duty pistol holstered and **LOADED**. This will expedite the process for shooting the pistol qualification.

The 2nd Quarter Range Qualification is a good opportunity to see how the patrol vehicle long guns are functioning. We will have spare parts and tools on hand should a weapon need a part or an adjustment.

No new weapons will be inspected or added to range cards during these range dates.

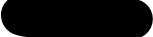

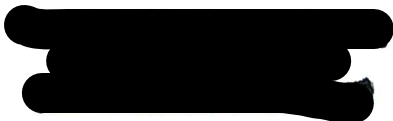

Please do not call for an appointment.

This intensive course focuses on dealing with mentally ill and developmentally disabled persons in crisis. The training includes interaction with subjects with disabilities and scenario based communication exercises. The student will be better prepared to respond to calls involving subjects in crisis, utilize de-escalation techniques to reduce the need for force and have a better understanding of services available as well as capabilities and competencies of the mental health system. Various subject matter experts, including law enforcement officers, psychologists and mental health advocacy groups will present.
