Bruening). **Applications must be received no later than February 16<sup>th</sup>, 2026.**

The first Academy class is scheduled for March 2<sup>nd</sup>, 2026, at 6:00 – 8:30 pm. Academy training sessions will then be held on Monday nights, from 6:00-830 pm, beginning and continuing through December 4<sup>th</sup>, 2025. You must be able to attend all these sessions. There will be one Saturday morning session held on May 9th, 2026, which will also consist of a graduation/celebratory BBQ or luncheon. Most classes will be held in the Lompoc Station but with some sessions held in Santa Barbara and Santa Maria.
